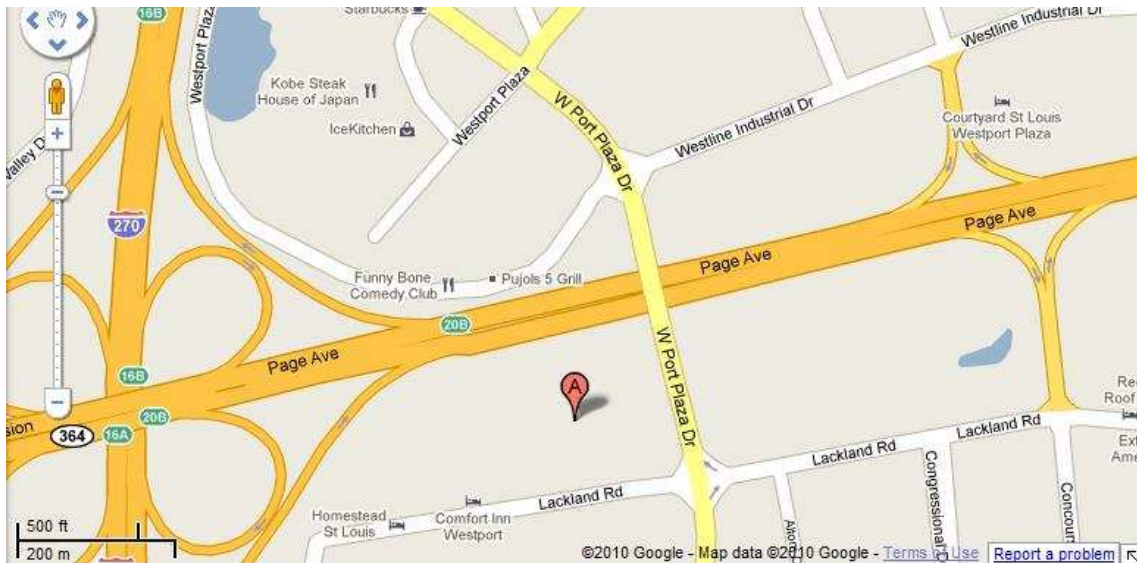
### Topic: **Johnson Controls, System 450 & other Refrigeration Product Updates.**
