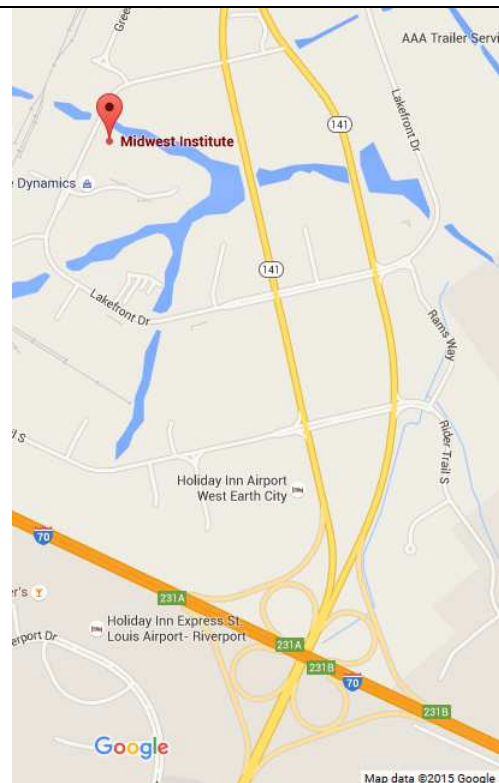
The Chapter Board of directors will meet immediately following the seminar to plan for future meetings. If you don't help, there may not be many more seminars.
